**Distribution of the Luxembourgish and Irish domiciled M&G Funds, managed by M&G Luxembourg S.A.**

We would like to advise you that M&G Luxembourg S.A., as management company of the M&G UCITS and AIFs ranges of funds (the 'Lux managed Funds' see listing overleaf) and having entered the Financial Conduct Authority's Temporary Permissions Regime ('TPR') in 2020, has now notified the Financial Conduct Authority that it will with effect from 30 September 2022 withdraw from the TPR. This means that M&G Luxembourg S.A. will no longer act as distributor of its managed Funds in the UK.

Consequently and with effect from 30 September 2022 M&G Luxembourg S.A.'s affiliate, M&G Investment Management Limited ('MAGIM') will, on behalf of M&G Luxembourg S.A., distribute the Lux managed Funds in the UK.

The appointment of MAGIM as sub-distributor of the Lux managed Funds in the UK will have no impact on Shareholders or Distributors contractual relationships with M&G.

We will with effect from 30 September 2022 make minor changes to our marketing materials and fund documents to reflect the appointment of MAGIM as sub-distributor of the Lux managed Funds in the UK.
